Sir,

As you are aware that 106<sup>th</sup> All India Trade Test under Apprenticeship Training Scheme (ATS) was conducted from 22.11.2017 to 30.11.2017 as per the guidelines issued vide this office letter of even no. dated. 28<sup>th</sup> September, 2017, 29<sup>th</sup> September, 2017 and 23<sup>rd</sup> October, 2017.

The first online exam for theoretical papers i.e. Theory, W/Sh. Calculation & Science and Employability skills was conducted online by the agency selected for this purpose by DGT. The online applications of the trainees was submitted by Establishments/State Apprenticeship Adviser(SAA)/Regional Directorate of Apprenticeship Training (RDAT) on website <http://dgt.cbtextam.in>.

It is observed by State Apprenticeship Adviser and RDATs that some of the Apprentices eligible to appear in 106<sup>th</sup> AITT under ATS in November, 2017 were not able to appear in online exam because of non-submission of online form at <http://dgt.cbtextam.in> due to some reasons.

The competent authority has looked into the matter and keeping in view the career of the trainees, has decided to conduct an another round of online exam for theoretical papers in **January, 2018**. The online registration in portal <http://dgt.cbtextam.in> for this proposed online exam will be open from **12<sup>th</sup> December, 2017 to 15<sup>th</sup> December, 2017**.

The left out candidates and the candidates, who have failed in the exams conducted during the period 28<sup>th</sup> November to 30<sup>th</sup> November, 2017 have to re-apply online for appearing in the proposed exam. The exam will be conducted at limited number of exam centres and dates will be decided after closing of online registration.

Therefore, it is requested to inform all the stakeholders under your control to adhere to the above date strictly to complete the registration of apprentices for online exam before **closing of portal on 15.12.2017 at 06:00 P.M.**
